



## 2023 Christ Church Outreach Grant Application for Grant Requests of \$5,000 or More

Each year through our grants program we look to fulfill our baptismal covenant to “proclaim by word and example the Good News of Christ, seek and serve Christ in all persons, loving our neighbor as ourselves, and to strive for justice and peace among all people, and respect the dignity of every human being.”

Grants will be awarded to non-profit agencies in Wake County or with international missions that are working to meet basic human needs and teaching life skills. We give special consideration to programs that: 1) have Christ Church involvement, 2) offer services to address downtown homelessness, and 3) have demonstrated responsible stewardship of their resources.

The allocation of funds and outreach efforts of the Christ Church community are coordinated by Outreach Ministries, a standing committee of the Vestry of Christ Church. All funding for outreach grants is made possible through received pledges.

All applications are **due by February 1, 2023** and must be submitted electronically to [OutreachMinistries@ccral.org](mailto:OutreachMinistries@ccral.org), including scanned information. List the agency name as the email subject. All applicants will receive notification by June and any money awarded will be distributed in late Fall 2023.
